1 Theory Course Assignment of Next Undergraduate Term (To begin in October 2009)

- The respected faculty members, who would leave for higher studies soon were not assigned any theory
 courses
- 2. In response to his request, Dr. A. S. M. Latiful Hoque was exempted from taking any theory courses.

2 Regarding the Course Number conflict

It was discovered that in the new CSE syllabus (January 2006), there exist 3 courses which have same number as 3 other courses offered by the department of CSE to the department of EEE. The course numbers of the corresponding courses were decided to be changed as follows:

- The undergraduate project/thesis (CSE 400) of the supervisees (0405079, 0405080) of Prof. Dr. Md. Shamsul Alam will be evaluated and graded by Dr. Mohammad Mahfuzul Islam.
- The advisees of Mr. Tanveer Awal ware transferred to Dr. A. S. M. Latiful Hoque. Mr. Tanveer Awal was requested to submit all the relevant documents to Dr. A. S. M. Latiful Hoque.
- 4. The issue of a Govt, initiative to double the number of intakes in ICT related programs was discussed.
