অত্র বিশ্ববিদ্যালয়ে ভবিষ্যতে র্যাগিং-এর সাথে জড়িতদের এবং সাংগঠনিক রাজনীতির বিভিন্ন কার্যক্রমে জড়িতদের অভিযোগসমূহ মূল্যায়ন ও শাস্তি নির্ধারণ বিষয়ে গঠিত কমিটির রিপোর্ট-এর আলোকে অভিযোগ প্রমানিত হওয়া সাপেক্ষে অভিযুক্তদের বিভিন্ন মেয়াদে শাস্তি নির্ধারণ করা হয়েছে। যা নিম্নরূপ :

The following table is a summarized version of punitive measures for the offences and penalties related to ragging and political involvement recommended by the Committee, to be read in conjunction with the Section 3.1 on Ragging of the Committee Report.

SI No	Offence	Grounds of Penalty	Scope of Penalty
1.	Ragging leading to death, serious bodily harm, any form of disability, permanent mental imbalance or trauma, disruption of academic life of a fellow student.	Moral Turpitude (no.23, Page 160)	Ordinarily, expulsion from the University for good and as appropriate, the university law officer shall file a case following due process on account of the university.
2.	Ragging involving verbal or physical abuse, extortion or financial hardship, shaming, temporary psychological harm, humiliation, threatening, disrupting academic life, planning discomfiture or being present during all of the above or commits any other offence which will be deemed by the authority as gross misconduct.	Misconduct (Gross) (no.22 & 24, Page 160; no.5a, Page 154)	Warning*, Fine**, Suspension from the hall for good up to Academic withdrawal/ barring for a period. The offender will have to go through psychological/social counseling for a period suggested by the university counselor prior to resuming academic life.
3.	Passively participating or being physically present during ragging, Exploiting the services or engaging a fresher for completing any academic task; Compelling a fresher to do errands or odd jobs or commits any other offence which will be deemed by the authority as minor misconduct.	Misconduct (Minor) (no.5a, Page 154)	Warning*, Fine** up to suspension from hall for a period. The student may be required to take Hum 109: Social Psychology or a course on Ethics (if not offered at BUET, the student may take the course at any tertiary level institution, BUET will regard it as an audit course only, the respective student advisor will ensure this and report to DSW.)


SI No	Offence	Grounds of Penalty	Scope of Penalty
1	Directly or indirectly conveying (through any media) ones political involvement; holding political posts or conducting political activities (including campaigning, participating in processions, meetings, putting up graffiti or posters, etc) in the university or associating the name of the university; forcing or inducing or inspiring others to take part in the above activities.	Breach of Discipline (No 16, Page 158; No 27,VII, Page 163)	Warning, imposing fine, suspension for any length of time, expulsion for good.

* In the case of a Warning, the information will be recorded in the respective student file by DSW and also displayed at the bottom of the student profile in BIIS, which respective advisers will be able to see. In case of a 2nd offence this will be taken into cognizance by the authority in deciding penalty. However, if the conduct of the student is satisfactory or rectified, the student may appeal as per university regulations for removal of the remark from the records.

** In case of imposition of a fine, the information will be displayed in BIIS as in the case of 'Warning', but the information about the disciplinary action will be in record during the period of studentship and DSW will issue appropriate statement indicating action in the Testimonial.
